

OVERVIEW:

Leadership Decision Making is tailored for senior-level executives from the public, nonprofit, and corporate sectors. The curriculum integrates theories and evidence from psychology, behavioral economics, and neuroscience. Participants will engage in live lectures, asynchronous materials, and group work, gaining insights from renowned Harvard faculty and experts. New sessions include topics on Artificial Intelligence (AI) and its impact on organizational decision processes, blending theoretical foundations with practical applications.

The Orange County Board of Education finds that professional development programs and/or continuing education of county board members should focus to enhance county board members' knowledge and effectiveness in the areas of:

- 4. New educational reform initiatives and research-based instructional strategies that enhance student achievement.

Approval

The Board collectively and/or Board members individually have the opportunity to seek and identify Professional development opportunities as set forth in Resolution #21-22. The Board member(s) shall present the Professional Development opportunity to the Board President. Should the Board President deem the Professional Development opportunity appropriate pursuant to Resolution # 21-22, the Board President may consult with Orange County Department of Education staff ("staff") regarding the propriety of the request. If the Board President and/or staff deem the request appropriate the request shall be tentatively approved.

Distribution

The Professional Development budget is intended to give the Board discretion, latitude and flexibility in seeking professional development opportunities. The Professional Development budget can, but need not, be distributed equally among Board members. The Board recognizes that each Board member may have differing priorities, experience, and/or personal circumstances which may impact their Professional Development participation.

Request and Reimbursement

Tentative approval shall constitute advanced approval allowing staff to access the Professional Development budget. In the event there is insufficient advanced notice Board member(s) may bear the cost of the Professional Development opportunity and subsequently seek reimbursement.

Ratification and Reporting

Professional Development ratification items shall be on the consent agenda, unless removed from the consent agenda by a Board member. Upon the request by two (2) or more Board members the Board Member(s) participating in the Professional Development shall publicly report on how and why the expenditure enhanced the Board member(s)' knowledge and effectiveness in the area set forth in Resolution #21-22.

RESOLUTION OF THE BOARD OF EDUCATION ORANGE COUNTY, CALIFORNIA

Resolution Establishing an Orange County Board of Education Professional Development Program and/or Board Continuing Education Fund

WHEREAS, the Orange County Board of Education is a service agency committed to supporting Orange County school districts and students; and

WHEREAS, the goal of the Orange County Board of Education is to ensure all students' success through extraordinary service, governance and boardsmanship; and

WHEREAS, the Orange County Board of Education values community input and is uniquely situated to identify emerging educational needs and inform the public on sound educational programs; and

WHEREAS, within the established statutory authority and responsibilities, the Orange County Board of Education's leadership role is expressed in the identification and modeling of appropriate methods, technologies, and practices; and

WHEREAS, the Orange County Board of Education recognizes and affirms that effective County boards ensure high academic standards, transparency, accountability and compliance; and

WHEREAS, the Orange County Board of Education has the statutory authority to adopt, evaluate and update policies consistent with California law and the Orange County Board of Education's vision and goals;¹ and

WHEREAS, the Orange County Board of Education has broad authority to carry out activities that are not in conflict with, inconsistent with, or preempted by law and which is not conflict with the purpose for which the County Board established;² and

WHEREAS, California Education Code section 1042 provides: "County Boards of Education may do the following: (a) adopt rules and regulations governing the administration of the office of the County Superintendent of Schools; and

WHEREAS, California Education Code section 1621(c) provides that the annual budget, "may contain a fund balance designated for any specific purpose as determined by the County

Board of Education. Those funds shall be available for appropriation by majority vote of the County Board of Education"; and

WHEREAS, the Orange County Board of Education finds that professional development programs and/or continuing education of county board members is integral for the Orange County Board of Education to successfully fulfill its mission, goals, and responsibilities;

WHEREAS, the Orange County Board of Education finds that professional development programs and/or continuing education of county board members is an investment in, and contributes to student success; and

WHEREAS, the Orange County Board of Education finds that the dedication of resources to professional development programs and/or continuing education of county board members is necessary for the effectiveness of individual Board members, and the collective board;

WHEREAS, the Orange County Board of Education finds that professional development programs and/or continuing education of county board members should focus to enhance county board members' knowledge and effectiveness in the areas of:

- 1. Governance and boardsmanship;
- 2. Board ethics;
- 3. State and federal legislation, and case law that affect the operation of County boards and local school districts; and
- 4. New educational reform initiatives and research-based instructional strategies that enhance student achievement.

WHEREAS, the Orange County Board of Education is committed to planning and programming its own professional development programs and/or continuing education for continued improvement.

THEREFORE, THE ORANGE COUNTY BOARD OF EDUCATION HEREBY RESOLVES AS FOLLOWS:

- 1. Pursuant to Education Code section 1621(c), the Orange County Board of Education shall establish a professional development program and/or county board continuing education fund.
- Passage of this resolution by majority vote shall constitute the majority vote required to make funds available for the specific purpose of establishing a professional development program and/or county board continuing education fund.

SUBJECT: Unity Middle College High School Issuance of a Notice of Violation

DESCRIPTION:

Consider issuing a Notice of Violation to Unity Middle College High School.

RECOMMENDATIONS:

The Orange County Department of Education recommends that the Orange County Board of Education issue a Notice of Violation to Unity Middle College High School and its Governing Board (Unity) pursuant to Education Code section 47607(g). Unity has engaged in fiscal mismanagement and failed to meet generally accepted accounting principles in its operations, as required under Education Code section 47607(f)(3). After issuing a Notice of Violation, the Board must provide a reasonable opportunity to remedy the violation.

In accordance with Education Code section 47607(g) and California Code of Regulations, Title 5 (5 CCR) section 11968.5.2, Unity shall have the opportunity to present evidence that refutes, remedies, or proposes to remedy the alleged violations. The Board will evaluate Unity's response to the Notice of Violation and may then determine whether to discontinue revocation or continue revocation by issuing a Notice of Intent to Revoke.

This correspondence is pending approval by the Orange County Board of Education (OCBE). If approved, it will be prepared on official letterhead, bearing the OCBE Seal, address, and contact information.

Re: Notice of Violation Pursuant to Education Code Section 47607(g)

Dear Board President Zulch, Executive Director Gonzales, and Unity Schools SoCal Governing Board:

This letter serves as a Notice of Violation (NOV) issued under Education Code section 47607(g). The Orange County Board of Education (OCBE) has determined that the Unity Schools SoCal Governing Board has failed to adhere to generally accepted accounting principles and has engaged in fiscal mismanagement in the operation of Unity Middle College High School (Unity). These violations jeopardize Unity's ability to continue operations.

Findings and Evidence of Violation

The Charter Schools Unit of the Orange County Department of Education (OCDE) has thoroughly documented its efforts to communicate and address concerns with Unity. In addition to informal communications via emails and phone calls, OCDE has issued twelve (12) Notices of Concern since Unity began operating in 2017, consistently highlighting concerns regarding Unity's fiscal condition.

OCBE has determined that the following issues and irregularities constitute multiple grounds for charter revocation under Education Code section 47607(f)(3):


1. Declining Enrollment and Overestimated Projections

Unity's enrollment projections for the 2024-25 school year have proven overly optimistic, with actual enrollment falling short. The school projected 75 students; however, it currently has only 57 enrolled, leading to a reduction in anticipated LCFF revenue by approximately \$234,876. Additionally, Unity's multiyear budget assumptions for the 2025-26 and 2026-27 school years are similarly overestimated, failing to account for the ongoing decline in enrollment observed since the 2019-20 school year.

Unity's projected student enrollment figures in the adopted budget versus the actual enrollment numbers reported in CALPADS (California Longitudinal Pupil Achievement Data System) for each school year from 2017-18 through 2024-25 indicates a pattern of overestimation when planning their budget. The gap between projected and actual enrollment is particularly large in the 2023-24 and 2024-25 school years. Enrollment peaked at 103 students in 2019-20 and has decreased since then, reaching only 55 students in 2023-24.



Unity's projected average daily attendance (ADA) compared with its actual reported ADA (P2-ADA) from the school years 2017-18 through 2023-24 indicates that Unity consistently overestimated its ADA. There is a declining trend in the actual ADA over time. Since ADA is directly tied to school funding, these discrepancies suggest that Unity's financial planning was overly optimistic, leading to budget shortfalls and fiscal instability.

2. Deficit Spending and Insufficient Reserves

Unity's financial records show a negative trend in its net assets, with a recorded loss of \$67,702 in the 2023-24 fiscal year, following a modest gain the previous year. This shift indicates that Unity struggles to manage its expenses, as its expenditures have consistently exceeded its revenue. Furthermore, the unrestricted net position is alarmingly negative, worsening from negative \$854,676 in 2022-23 to negative \$948,505 in 2023-24. This deficit suggests the school lacks sufficient funds to cover its operational costs.

Additionally, the declining ending net assets, which dropped from \$377,487 in 2022-2023 to \$328,957 in 2023-24, highlight a concerning depletion of the school's resources. The capital assets, while substantial, do not offset the urgent need for liquid funds, leaving the school in a precarious financial state. The inability to manage unrestricted funds effectively puts Unity at risk of insolvency, which could disrupt the educational environment for students and the school community.

OCDE's 2024-25 fiscal year projections indicate further deficit spending of \$152,839 and a projected unrestricted net position at negative \$1,077,600. Unity lacks adequate reserves to manage financial uncertainties, creating an unsustainable financial situation.

3. Mounting Debt and Potential Default

Unity faces significant financial distress, highlighted by its mounting debt and recent loan activities. Unity has accumulated a total debt of \$650,000 in loans, including a new loan of \$100,000 due in December 2024, just two months away.

a. At the Unity Board meeting on June 27, 2024, Roy Kim, Chief Operating Officer of ICON School Management, recommended that the Board approve a \$200,000 loan extension from private investor Sangyoon Han. Mr. Kim explained that according to the financials and

proposed budget he presented, Unity could not meet its current loan obligation, which required a \$200,000 payment on June 1, 2024. He further stated that even under the proposed budget, which assumed an enrollment of 75 students, Unity could only repay approximately \$50,000 by the new deadline of June 1, 2025, necessitating renegotiation of the remaining balance.

b. On October 2, 2024, OCDE notified Unity about its enrollment numbers and fiscal stability concerns. OCDE cited Unity's own statements indicating a high likelihood of defaulting on loans due in June 2024. Despite these warnings, the Unity Board proceeded on October 8, 2024, to approve a short-term loan of \$100,000 from private investor Andy Kim, with repayment due on December 4, 2024. This decision was made despite the Board's awareness of Unity's inability to meet its other loan commitments, indicating a pattern of risky financial behavior. The loan was justified to address Unity's ongoing "cash flow situation." However, given Unity's insufficient revenue and current financial state, the risk of default remains substantial, further endangering the school's financial stability.

4. Inadequate Fiscal Recovery Plan

Despite OCDE's requests, Unity has not implemented a viable fiscal recovery plan. The most recent Unity board-approved plan, adopted in February 2024, acknowledged that serving fewer than 100 students would be financially unsustainable. The plan necessitated increasing enrollment to 85 students in the 2024-25 school year. With enrollment falling short by 28 students, Unity has been unable to stabilize its financial position.

Additional Concerns

1. Fiscal Policy

The promissory note for the \$100,000 loan was executed by Unity's Executive Director, Lauren Hunsberger-Gonzales, on October 4, 2024, prior to receiving formal board approval on October 8, 2024. This raises serious governance and oversight issues. Major financial decisions, especially those involving substantial sums of money, should not be finalized without explicit board authorization.

The situation is further exacerbated by Unity's lack of a fiscal policy specifically addressing third-party loans. Without clear guidelines on handling such transactions, the school is at greater risk of entering into financial agreements that could jeopardize its stability. Well-defined policies are critical for ensuring that financial decisions are made with transparency and in accordance with the organization's best interests.

2. Facility Lease Agreement Automatic 5-Year Renewal Provision

The term of Unity's current lease for its facilities runs from July 1, 2021, to June 30, 2026. The rent has increased incrementally each year and is currently set at \$21,891.66 per month and will increase to \$22,548.11 on July 1, 2025, through June 30, 2026. However, the lease agreement includes an automatic renewal clause for another five years. The option to move out must be exercised by Unity by giving at least eighteen (18) months' written notice to the landlord before the expiration of the term. Absent Unity's failure to notify the landlord eighteen months prior to the expiration of the term of their intent to move out, the lease will automatically renew for another five (5) years with the rent increase equal to the amount of the Consumer Price Index (CPI) for each year of the extended term, but not less than 4%. Consequently, Unity must notify its landlord of its intent to move out of its current property by December 30, 2024; otherwise, Unity will be locked into another five-year lease with its landlord.

In light of Unity's financial condition, future enrollment projections and operation needs, Unity must make an informed decision before the December 30, 2024, deadline to avoid being obligated by the terms of the agreement for an additional five-year period after June 2026.

Right to Respond to Violation

Pursuant to *California Code of Regulations*, Title 5 (5 *CCR*) Section 11968.5.2, the Unity Board has the right to respond to this NOV through the following actions:

- 1. Submit to OCDE a detailed, written response addressing each identified violation, which shall include the refutation, remedial action taken, or proposed remedial action by the charter school specific to each alleged violation. The written response is due by 5:00 p.m. on Wednesday, November 20, 2024, via email at ADay@ocde.us and RHendrick@ocde.us.
- 2. Include, with its written response, supporting evidence of the refutation, remedial action or proposed remedial action, if any, including written reports, statements, and other appropriate documentation.

Failure to provide substantial evidence that refutes, remedies, or proposes to remedy the alleged violations may provide grounds sufficient to form the basis for an action to revoke the Unity Middle College High School Charter, pursuant to Education Code section 47607(f).

Pursuant to 5 *CCR* 11968.5.2, OCBE will evaluate the response by the Unity Board to determine whether the identified violations have been adequately addressed as to Unity's financial stability or if it is necessary to continue the revocation process by issuing a Notice of Intent to Revoke the school's charter.

SUBJECT: Revised Board Policy 300-2, Inter-district Attendance Appeal Hearings

RECOMMENDATION:

Board discussion regarding Revised Board Policy 300-2, inter-district attendance appeal hearings.

Interdistrict Attendance Appeal Hearings

The Orange County Board of Education is committed to parental rights and parental choice. The Orange County Board of Education is also sensitive to the rights, responsibilities and issues of local school districts.

The parent and/or person having legal custody of a pupil may file a formal appeal to the Orange County Board of Education after the failure or refusal of the governing board of either school district to issue a permit, or to enter into an agreement allowing the attendance.

The Orange County Board of Education shall, after the formal appeal is filed, determine whether the pupil should be permitted to attend in the district in which the pupil desires to attend and the applicable period of time.

The Orange County Superintendent of Schools or the Orange County Superintendent of Schools' designee shall establish procedures and timelines that will meet the Education Code requirements regarding inter-district attendance appeal hearings.

The Orange County Board of Education considers the level of commitment of the parties in their respective positions, as demonstrated in part through a personal appearance at the appeal hearing, to be an important factor in reaching its determination. Accordingly, any parent, guardian or entity choosing to participate in any appeal hearing shall appear in person. However, the Orange County Board of Education recognizes that circumstances beyond the control of the respective parties may make an in-person appearance impractical or impossible. Such circumstances may include, but are not limited to, the following:

- A documented medical disability or condition
- Unavoidable travel outside of Orange County
- Other extenuating circumstances (examples include immigration issues, court appearances, jury duty)
- Health and Safety Concerns: If there's a risk to participants due to a chronic medical condition or general concerns about public health.
- Travel Constraints: Unforeseen issues like flight cancellations, bad weather, or road closures can hinder participants from attending in person.
- Emergency or Unexpected Events: If something urgent arises that requires rescheduling or remote options.
- Accommodation for Disabilities: For participants with mobility challenges or health conditions that make travel difficult

The Orange County Board of Education will consider a number of issues in the best interests of the pupil in family when hearing an inter-district appeal, including, but not limited to, the following:

- 1. The transportation needs of the family;
- 2. The childcare needs of the family;
- 3. Other siblings in the family. For example, when the pupil has a sibling or other member of the household attending school in the receiving district, to avoid splitting the family or household's attendance;
- 4. The continuity of the child's current educational program (e.g., completion of elementary school,

middle school or high school). For example, to allow the pupil to complete a school year when his or her parents or guardians have moved out of the district during the year;

- 5. The parent's place of employment;
- 6. The pupil's psychological or physical well-being. A problem with the pupil's psychological or physical well-being may be supported by the written statement of a qualified professional;
- 7. A substantial danger to the pupil health or safety. Specifically, harmful or dangerous circumstances or health issues that exist in the current attendance area which will be substantially mitigated by attendance and another district. The danger to the pupil health or safety may be supported by a written statement of a qualified health expert, police report, school record, or other documentation;
- 8. A specialized and specific academic program or service, unavailable in the district of residence but necessary to the pupil's career or academic objectives. Such a program or service must be related to the pupil's career objectives or academic advancement and not based solely on the pupil's interests or desires, or on extracurricular activities or athletics. This criterion does not apply to elementary education programs;
- 9. Hardship resulting from a lack of available or appropriate afterschool options for the pupil in the district of residence. The parent or legal guardian must demonstrate attempts to find appropriate childcare in the district of residence and must describe these attempts in the written materials provided when the appeal is filed;
- 10. A severe and demonstrated hardship to parents/guardians which can affect a pupil's success in school. The parent/guardian must specify and describe the type of hardship in writing: "hardship" shall be understood to exclude inconvenience to the parents or matters of preference;
- 11. The pupil's desire to remain in his/her school or current attendance for the balance of the semester of the school year. The pupil's desire may be based on his/her anticipated promotion from the school or current attendance at the end of the semester or school year or on a need for education no continuity for the remainder of the semester or school year;
- 12. The pupil's and/or parent/guardian's plan to move in the near future and desire to begin the semester or school year in his or her new school district. The pupil and his/her parent/guardian may offer written proof of their plan to move into the district of proposed attendance; such written proof may be a rental agreement, a contract to purchase new property, or similar document:
- 13. When recommended by the School Attendance Review Board, County Child Welfare, probation or social services agency staff in document cases of serious home or community problems which make it inadvisable for the pupil to attend the school of residence;
- 14. The financial impact of educating the pupil (district of proposed attendance) or losing the pupil (district of residence). In either case impacted district(s) must demonstrate in writing that the pupil's transfer would place a unique hardship on the district's resident pupils in terms of reduced services or other acceptable outcomes;
- 15. The pupil's demonstrated failure to meet reasonable standards relating to behavior, attendance or diligence to studies. The demonstration of such failure must be based on a written explanation of the district's previous experience with the pupil under an interdistrict transfer agreement or other documented evidence;

- 16. Lack of space for the pupil in the receiving district. The district of proposed transfer must demonstrate in writing that the pupil's transfer would result in an undue hardship to the district's resident pupils in terms of overcrowding and/or would be a violation of a collective bargaining agreement regarding class-size and goals. The District must demonstrate that the undue hardship outweighs the hardship to the pupil;
- 17. Other exceptional or extraordinary circumstances which could weigh heavily in favor of the upon pupil or the affected school district. The parent/guardian or school district must specify and describe the type of exceptional or extraordinary circumstance and its effect on the appellant pupil or the resident pupils of the district.
