

As required by Education Code Section 1240 (I) county offices of education are required to submit to the Superintendent of Public Instruction a First Interim Report and a Second Interim Report. The first report shall cover the financial and budgetary status of the county office of education for the period ending October 31. The second report shall cover the period ending January 31. Both reports shall be reviewed by the county board of education and approved by the county superintendent no later than 45 days after the close of the period being reported.

The superintendent shall certify in writing whether or not the county office of education is able to meet its financial obligations for the remainder of the fiscal year and two subsequent years. The certifications shall be classified as positive, qualified, or negative, pursuant to standards prescribed by the Superintendent of Public Instruction.

RECOMMENDATION:

Board action on Revised Board Policy 300-2, inter-district attendance appeal hearings.

Interdistrict Attendance Appeal Hearings

The Orange County Board of Education is committed to parental rights and parental choice. The Orange County Board of Education is also sensitive to the rights, responsibilities and issues of local school districts.

The parent and/or person having legal custody of a pupil may file a formal appeal to the Orange County Board of Education after the failure or refusal of the governing board of either school district to issue a permit, or to enter into an agreement allowing the attendance.

The Orange County Board of Education shall, after the formal appeal is filed, determine whether the pupil should be permitted to attend in the district in which the pupil desires to attend and the applicable period of time.

The Orange County Superintendent of Schools or the Orange County Superintendent of Schools' designee shall establish procedures and timelines that will meet the Education Code requirements regarding inter-district attendance appeal hearings.

The Orange County Board of Education considers the level of commitment of the parties in their respective positions, as demonstrated in part through a personal appearance at the appeal hearing, to be an important factor in reaching its determination. Accordingly, any parent, guardian or entity choosing to participate in any appeal hearing shall appear in person. However, the Orange County Board of Education recognizes that circumstances beyond the control of the respective parties may make an in-person appearance impractical or impossible. Such circumstances may include, but are not limited to, the following:

- A documented medical disability or condition
- Unavoidable travel outside of Orange County
- Other extenuating circumstances (examples include immigration issues, court appearances, jury duty)
- Health and Safety Concerns: If there's a risk to participants due to a chronic medical condition or general concerns about public health.
- Travel Constraints: Unforeseen issues like flight cancellations, bad weather, or road closures can hinder participants from attending in person.
- Emergency or Unexpected Events: If something urgent arises that requires rescheduling or remote options.
- Accommodation for Disabilities: For participants with mobility challenges or health conditions that make travel difficult

The Orange County Board of Education will consider a number of issues in the best interests of the pupil in family when hearing an inter-district appeal, including, but not limited to, the following:

- 1. The transportation needs of the family;
- 2. The childcare needs of the family;
- 3. Other siblings in the family. For example, when the pupil has a sibling or other member of the household attending school in the receiving district, to avoid splitting the family or household's attendance;
- 4. The continuity of the child's current educational program (e.g., completion of elementary school,

middle school or high school). For example, to allow the pupil to complete a school year when his or her parents or guardians have moved out of the district during the year;

- 5. The parent's place of employment;
- 6. The pupil's psychological or physical well-being. A problem with the pupil's psychological or physical well-being may be supported by the written statement of a qualified professional;
- 7. A substantial danger to the pupil health or safety. Specifically, harmful or dangerous circumstances or health issues that exist in the current attendance area which will be substantially mitigated by attendance and another district. The danger to the pupil health or safety may be supported by a written statement of a qualified health expert, police report, school record, or other documentation;
- 8. A specialized and specific academic program or service, unavailable in the district of residence but necessary to the pupil's career or academic objectives. Such a program or service must be related to the pupil's career objectives or academic advancement and not based solely on the pupil's interests or desires, or on extracurricular activities or athletics. This criterion does not apply to elementary education programs:
- 9. Hardship resulting from a lack of available or appropriate afterschool options for the pupil in the district of residence. The parent or legal guardian must demonstrate attempts to find appropriate childcare in the district of residence and must describe these attempts in the written materials provided when the appeal is filed;
- 10. A severe and demonstrated hardship to parents/guardians which can affect a pupil's success in school. The parent/guardian must specify and describe the type of hardship in writing: "hardship" shall be understood to exclude inconvenience to the parents or matters of preference;
- 11. The pupil's desire to remain in his/her school or current attendance for the balance of the semester of the school year. The pupil's desire may be based on his/her anticipated promotion from the school or current attendance at the end of the semester or school year or on a need for education no continuity for the remainder of the semester or school year;
- 12. The pupil's and/or parent/guardian's plan to move in the near future and desire to begin the semester or school year in his or her new school district. The pupil and his/her parent/guardian may offer written proof of their plan to move into the district of proposed attendance; such written proof may be a rental agreement, a contract to purchase new property, or similar document:
- 13. When recommended by the School Attendance Review Board, County Child Welfare, probation or social services agency staff in document cases of serious home or community problems which make it inadvisable for the pupil to attend the school of residence;
- 14. The financial impact of educating the pupil (district of proposed attendance) or losing the pupil (district of residence). In either case impacted district(s) must demonstrate in writing that the pupil's transfer would place a unique hardship on the district's resident pupils in terms of reduced services or other acceptable outcomes;
- 15. The pupil's demonstrated failure to meet reasonable standards relating to behavior, attendance or diligence to studies. The demonstration of such failure must be based on a written explanation of the district's previous experience with the pupil under an interdistrict transfer agreement or other documented evidence:

- 16. Lack of space for the pupil in the receiving district. The district of proposed transfer must demonstrate in writing that the pupil's transfer would result in an undue hardship to the district's resident pupils in terms of overcrowding and/or would be a violation of a collective bargaining agreement regarding class-size and goals. The District must demonstrate that the undue hardship outweighs the hardship to the pupil;
- 17. Other exceptional or extraordinary circumstances which could weigh heavily in favor of the upon pupil or the affected school district. The parent/guardian or school district must specify and describe the type of exceptional or extraordinary circumstance and its effect on the appellant pupil or the resident pupils of the district.

RESOLUTION OF THE BOARD OF EDUCATION ORANGE COUNTY, CALIFORNIA

Establishing Institutional Membership in the Association of California County Boards of Education

December 4, 2024

WHEREAS, County Boards of Education are enshrined in the California Constitution, and as such are constitutional offices. The 58 county boards play an integral role in education since their creation commencing in 1860.

WHEREAS, in addition to the appellate role that they play, County Boards have led important, educational reform, promoted innovative measures for County Offices of Education, insured fiscal integrity of County offices, and promoted critical policy changes to benefit California's students, including the most vulnerable, at promise, children.

WHEREAS, it is important for County Board members to have a strong independent voice to advocate for the critical needs of students, and communities they serve. County Offices and Boards of Education play uniquely vital roles, impacting every school and student across California. Their responsibilities encompass supporting students and families facing significant challenges, including those in programs for students with disabilities, early childhood education, foster and homeless youth, and court and community, and need a statewide representative voice.

WHEREAS, creating and supporting the Association of California County Boards of Education (ACCBE) strengthens our ability to advocate for the needs of County Offices of Education and provides additional support for public education statewide. Establishing ACCBE as a statewide county board organization brings a unified, strong voice representing the unique interests of County Boards on issues impacting County Offices of Education and provides a vehicle to advocate for the needs of students we serve, ensuring these needs are not overlooked in the legislative process. As a dedicated advocate for students, this organization will join other educational organizations to champion public schools and adequate funding.

WHEREAS, County Boards similarly have a proactive future focused mission on behalf of California's family and children, especially at promise families and children.

WHEREAS, the primary objectives and purposes of ACCBE shall be the improvement of public education by supporting the work of California County Boards of Education and their members and advocating on their behalf.

NOW, THEREFORE, BE IT RESOLVED, that the Orange County Board of Education will join the Association of California County Boards of Education as an institutional member.

BE IT FURTHER RESOLVED, the Orange County Board of Education will encourage its board members to play leadership roles in this important association.

BACKGROUND:

In order to recruit and retain high quality candidates for positions within the organization, the Department has prided itself in maintaining a competitive salary and benefits package. Accordingly, the Department has made efforts to remain competitive with salaries in the upper quadrant among similar Orange County school districts and county offices.

In accordance with Education Code Section 1302 and Board Policy 100-10, attached is information for all employees who will receive a salary increase of more than \$10,000 in a 12-month period since we last reported in November 2023. The \$10,000 limit was set in statute in 1999, and has not been adjusted since October 2024.
